In terms of Railway Board's letter No.E(NG)-II/2007/RC-4/Core/1 dated 16.10.2017 & 12.12.2017 and PCPO/ECOR/BBS clarification letter dtd.16.03.2018, it has been decided to fill up the following vacancies of Technician Gr.III in the designated trade for re-engagement in Mechanical Department of CRW/MCS as per terms and conditions given below.


Terms and Conditions of re-engagement of retired employees.

1. The Scheme is valid up 01.02.2019.
2. Employees retired from Railway services in designated trades.
3. The re-engagement shall be strictly up to the age of 65 years or up to 01.12.2019 or till the availability of regular candidates from RRB/Departmental Selections, whichever is earlier.
4. The maximum upper age limit for the re-engagement of employees is 65 years. No re-engaged employee shall continue in service beyond 65 years of age.
5. The administration is at liberty to terminate the services of the re-engaged employees even before 01.12.2019 in case their work/conduct is found unsatisfactory.
6. The employees Removed/Dismissed/Compulsory retired as a result of disciplinary action or in review are not eligible for re-engagement. Further, employees retired under SRRS/LARSGESS will not be eligible.
7. The re-engaged staff will be paid monthly remuneration determined by reducing pension from his/her last pay drawn (i.e., Basic+DA). The re-engaged employees are not entitled for any other benefits or facilities except the monthly remuneration.
8. The retired employee shall execute an agreement to abide by all the terms and conditions of the re-engagement.
9. Re-engagement shall be subject to prescribed medical fitness for the post.
10. Suitability/ Competency of the applicant shall be adjudged by competent authority before their re-engagement through Service record, Skill and Safety record as well as the Safety and other operational requirement as needed are adequately addressed.
11. The re-engaged retired employee will have to give 7days notice for discontinuing the service.

12. Re-engaged employees shall be on duty on normal duty hours followed by the office in which they will be posted. The duty hours can be changed as per the requirement of work by the administration. They will be eligible for weekly off and General Holidays observed by the office in which they will be posted. The re-engaged employee will not be eligible for any kind of leave (like CL, RH, LAP, Sick leave etc.). For absence if any, appropriate deduction will be made from the monthly remuneration.
13. Self attested copies of the following documents should mandatorily be attached with the application:
- (a) Service Certificate
 - (b) Pensioner Identity Card
 - (c) Pension Payment Order
 - (d) Aadhaar Card.
14. The last date of submission of the application is **21.04.2018. (Saturday upto 13.30 hrs.)**
