

STAFF SELECTION COMMISSION

Subject: Combined Higher Secondary Level (10+2) Examination, 2016 for recruitment of Lower Division Clerk (LDC), Court Clerk, Postal Assistant/ Sorting Assistant and Data Entry Operator (DEO) - Declaration of Final Result - reg.

Staff Selection Commission declared 41,326 candidates qualified for appearing in Typing Test for the post of Lower Division Clerk, Court Clerk, Postal Assistant/ Sorting Assistant; 5,766 candidates qualified for Skill Test for the post of DEO in CAG and 344 candidates qualified for Skill Test for the post of DEO in Departments other than CAG.

DEO in CAG	Tier-I, Tier-II and DEST (15,000 key depressions per hour.)
DEO in Departments other than CAG	Tier-I, Tier-II and DEST (8,000 key depressions per hour.)

5. **Resolution of Tie cases:**

In case where more than one candidates secure the equal aggregate marks, tie has been resolved by applying the following methods one after another in the given order:

- i) Marks in first part of the Written Examination (Tier-I).
- ii) Date of Birth, with older candidates placed higher.
- iii) Alphabetical order in which first names of the candidates appear.

6. Category wise break-up of the candidates selected for the posts of Lower Division Clerk, Court Clerk, Postal Assistant/ Sorting Assistant and Data Entry Operator along with the Total Marks obtained by the last selected candidates are given below. In cases where candidates are selected against horizontal vacancies (3-ExS, 4-OH, 5-HH, 7-VH), Total Marks of such last selected candidates are reflected against their respective horizontal category, not against their vertical category (1-SC, 2-ST, 6-OBC, 9-UR).
