<b>Pay Scale</b>	PB-I, Pay Band- Rs. 5200-20200 + Grade Pay Rs. 2800 (Pre-revised).																									
<b>Age as on 01.12.2017 :- (18 TO 27 years).</b>	Age limit is relaxable by 5 years in case of SC/ST, 3 year in case of OBC, 10 years in case of persons with disabilities and in case of Ex-Servicemen/Serving Government employees as per rules.																									
<b>Minimum Educational Qualification</b>	Graduation or equivalent from a recognized university with English typing @ 40 w.p.m. <b>Note:-</b> Candidate should have adequate working knowledge of computer shall be given preference.

		2. The candidates who will be declared qualified in Written Test (as per merit) will be called to appear for typing test @ 40 w.p.m. in English on computer in 10 minutes.																								
		3. The candidates who qualify the Typing Test shall only be shortlisted for interview.																								
01. The applications should be submitted <b>ONLY ONLINE</b> at Delhi Courts website i.e. <a href="http://delhidistrictcourts.nic.in">www http://delhidistrictcourts.nic.in</a> . Applications will not be entertained by any other mode. Candidates must possess a valid <b>E-Mail ID and a Mobile number</b> to fill up the online form.																										
02. The Online filling up of application will start at 10:00 AM (IST) on <b>11.11.2017</b> and will end at 5:00 PM (IST) on <b>01.12.2017</b> after which the link will be disabled and no application will be entertained.																										
03. A non-refundable online fee of Rs. 300 (Rupees Three Hundred Only) will be payable by male General as well as OBC candidates along with applicable transaction charges. No fee shall be charged from the SC/ST/Persons with disability/Ex-Servicemen and Woman Candidates. It is clarified that the fee once paid shall not be refunded under any circumstances.																										
04. The candidates shall appear in the Written Test/Typing Test and Interview at their own expense. No T.A./D.A will be admissible.																										

05. The dates for holding the written test, typing test and interview, Admit Cards, for appearing in the tests, results and other information will be uploaded on the official website of the Delhi District Courts. **The candidates are required to check the official website of this office in regularly on their own for information. The office shall not intimate individually to any candidates.**
06. The candidates applying for the examination should ensure that they fulfil all the eligibility conditions for appearing in this examination. The candidature of the candidates will be purely provisional at all stages and will be subject to their satisfying the prescribed eligibility conditions. If at any stage before or after the written test, typing test or interview, it is found that any candidates does not fulfil any of the eligibility conditions, or the information furnished by the candidates is found incorrect, his/her candidature for the examination shall stand cancelled without any notice or further reference.
07. Only OBC (Delhi) candidates will be given the benefit of reservation/age relaxation under OBC.
08. OBC (Outside Delhi) candidates will be treated as unreserved candidates.
